 Commissioner of Lands;

**THE JUDICATURE (RULES OF COURT) LAW, 1961**  
 (Law 21 of 1961)

**THE LEGAL PROFESSION ACT, 1971**  
 (Act 15 of 1971)

**THE LEGAL PROFESSION (ENROLMENT AND PRACTISING CERTIFICATE FEES) RULES, 1971**  
 In exercise of the powers conferred on the Rules Committee of the Supreme Court  
 by section 4 of the Judicature (Rules of Court) Law, 1961, and by virtue of section 4  
 of the Legal Profession Act, 1971, and all other powers hereunto enabling the  
 following Rules are hereby made:—

1. These Rules may be cited as the Legal Profession (Enrolment and Practising  
 Certificate Fees) Rules, 1971, and shall come into force on the 3rd day of  
 January, 1972.

2. Any person who possesses the qualifications for enrolment shall be entitled  
 upon application to the Supreme Court to have his name entered on the Roll  
 kept by the Registrar of the Supreme Court pursuant to section 4 of the Legal  
 Profession Act, 1971 (hereinafter referred to as "the Act").

3. The application for enrolment shall be by notice of motion supported by  
 affidavit and the motion may be heard by a single Judge.

4. The notice of motion and a copy of the affidavit shall be served on the Secretary of the General Legal Council and there shall be exhibited with the affidavit the following documents:—

- (i) The qualifying certificate from the Legal Education Authority, or, where the application is made pursuant to subsection (2) of section 6 of the Act, a certificate from the General Legal Council stating that the Council is satisfied that the applicant is qualified to practise law in a country having a sufficiently analogous system of law and that his qualifications are such as to render him suitable for enrolment, and that he has complied with any conditions prescribed by regulations made under section 10 of the Act.
- (ii) A certificate from the General Legal Council stating that the Council is satisfied that the applicant has attained the age of twenty-one years, is not an alien and is of good character.
- (iii) An official receipt or other satisfactory proof of the payment of the prescribed fee set forth in Part I of the Schedule of Fees hereafter appearing as the First Schedule.

5. The applicant shall appear in person before the Court and shall subscribe his signature to the Roll and take the Oath of Office in the form set out in the Second Schedule hereto.

6. The Registrar of the Supreme Court shall thereafter sign and seal with the seal of the Court and cause to be delivered to the Applicant a Certificate of Enrolment in the form as appears in the Third Schedule hereto.

7. It shall be the duty of the Registrar to notify the Secretary of the Council of the name and address of every person whose name has been entered on the Roll or removed from the Roll and to publish in the Jamaica Gazette the names and addresses of all such persons.

8. The fees to be charged in relation to the issue of practising certificates shall be those set out in Part II of the Schedule of Fees hereafter appearing.
